Japanese Knot Weed: There is concern from local residents that 20 Tye Green has Japanese Knot weed all over the garden. The neighbour has been spoken to and they said that they removed the knot weed last year. The knotweed has been reported to UDC. David Corke: Ellis Green is a designated local wildlife site with public access. 1 acre is private land when belongs to Walden Countryside and other is commonland and no known owner. The management is carried out by local farmers. The area that would benefit from management is the area around the old moat and the pond needs management. The orchard is managed by Walden Countryside and it is in need of extra work. Neighbouring parishes have larger amount of open access countryside but they are not areas in PC management. Wimbish has the commonland to manage and own Lucy May field, which should be made available to the general public and available for everyone. Ecology details sent to the David Corke and need to discuss how the projects are going to be kept going. The issue is with getting volunteers to be involved in projects. FWAG are coming to visit for free initial advice for a management plan for the land. Lucy May field needs to be discussed. Sometimes planting trees isn't the right solution, and should be left to their own devices. Lucy May field is a site on a very busy road and no parking. The PC wasn't allowed to touch the pond by Stewardship a number of years ago.
