The PC asked Stewart Luck to call in the application and ask for a site visit. b) Solar Farms There has been no formal application for the Solar Farm, it was just as a request for screening to UDC, and PC and residents cannot make comments. The three combined proposed solar farms is 160 hectares with Radwinter and Wimbish (400 acres). There are lots of other issues and risks associated to the application including the loss of Grade 2 agricultural land, harm to the rural character, impact on wildlife, loss of amenity of footpaths and bridleways, noise and traffic and construction traffic. Two new substations, CCTV cameras, access road, excavation of underground cabling. Two positive options are stopping housing and add to renewables. Cole End Solar Farm is only half built and there is no logical way for this stie to connect. The cost of running underground is cost prohibitive. c) Allington Homes/Carver Barracks A week after the meeting Allington took the fences were taken down from the Sewerage Works due to a H & S report. The PC suggested that residents/Chris contacts Allington Homes and Anglian Water and if further help is required contact Citizens Advice Bureau to ask who would be the Obersman for property management company.

The planning application and location plans include drawings of an enlarged access road which differs significant from that approved (UTT/24/1382/HHF, Condition 5), permission for the change is not sought in this or other current planning applications submitted for comment. As the access design is implicit to this planning application, the Parish Council believe the application is incomplete in its current form.

Should the application to separate the properties be approved the Parish Council object to an increase in size of the access across the verge. Large private hard standings on public land (such as double width driveways and turning areas) set an unhelpful precedent along the protected lane where other properties may also seek to expand their parking onto the wide verge.
